She was born 20 Nov 1790 in Wilkes Co., NC, and died 14 Oct 1862 in Paragon, Morgan County, IN.

Living next door is dau. Martha & Samuel Peters & family. Lucinda may be at her uncle William Baker's house. William's father George is living with William Baker & family, there is a girl, age 5-10, living with them. William did not have a daughter of that age, so this is possibly Lucinda.

In 1850, Christopher Bolen, age 63 and b. in Tennessee, and wife Nancy, age 60 and b. in N.C., are living in Morgan Co., IN, Washington twp, Balaam Bolen and Stephen Bolen are still at home. Christopher is a farmer. Christopher Jr and family are living next door.

In 1860, Christopher, age 74 and b. TN, & Nancy Bowlin, age 70 and b. N.C., are living in Martinsville, Morgan Co., IN. Christopher is a farmer. Stephen & Ellen Bowlin are living next door and next to them is Balam Bowlin & family. Wiley Burns is also nearby.

In 1870, Christopher Bolen, age 82 and b. TN, is living with Stephen & Ellen Bolen and family in Morgan Co., Washington twp, IN. Balaam and family are next door.

DEATH NOTICE:

From the Martinsville Republic, Oct 12, 1876, page 5, col. 2:

"Uncle Christopher Bolin departed this life Friday, Oct. 6th, of old age. He was a veteran of Kentucky; was one of the first settlers of this county, and at the time of his death had arrived at the extreme age of ninety-four years."

Christopher Bolen applied for Land Patent #31543 on Feb. 3, 1837 (land description above) for 40 acres in Morgan Co., IN. Christopher did not write so his son-in-law, Samuel Peters, signed the application for him. Christopher signed his mark on the following affidavit:

I do solemnly swear that I wish to purchase the N.W. 1/4 of Section No. 35 in Township 11 N. of Range 1 West for my own use and not in trust for any other person. I intend the same for the purpose of cultivation, and I have not heretofore purchased at any Land Office in the U.S. a qr of a qr of Section of land in my own name or in the name of any other person

Notes for MARTHA BOLIN:

The Martinsville Republican, 2 May 1906:

Mrs. Martha Peters, who lived south of this city, in Monroe county, died yesterday afternoon at two o'clock. Deceased was ninety-seven years of age and death was due to failing health resulting from old age. She is survived by four sons and three daughters. The interment was made this afternoon in Union Cemetery, Baker township, at three o'clock.

Martha and Samuel Peters land adjoined her brother Christopher Bolin's land in Washington twp, Monroe Co., IN. in 1856. The northern border of their land adjoined Morgan county line.

Samuel and Martha probably married in Kentucky before arriving in Indiana. Marriage record has not been found.

In 1860, Martha Peters, age 46, lives in Monroe Co., Washington twp, IN, P.O. Bryant's Creek. With her are her children John, Mary Jane, Feriba, Bedford, Baalam, and Jesse.

In 1870, Martha Peters and children Henry H, Christopher, Rebecca J., Bedford, Balam, Jesse and 2 children who are probably grandchildren - John B. Peters - 1, and Rue? or Ruth? J. - 1 mo. Also living with Martha is her daughter Ferriba Williams - 24. Son John, wife Surilda? and their daughter, Martha - 1, are next door.

Uncle Balam Bolin was born in eastern Kentucky, on the south fork of the Kentucky River, in Clay county in 1829. When four years old emigrated with his parents to Morgan County, Indiana, in which county he has lived continually ever since. On August 10, 1862, he enlisted in the 67th Regt., Ind. Volunteers, was taken prisoner with his regiment at Manfordsville, Kentucky, about September 15th or 20th. While a paroled prisoner he was taken sick, and confined to the hospital some eight month, and then discharged on account of disability, for which he is now drawing a pension. On the 4th inst. being the 57th anniversary of his birthday, the boys decoyed the old man off several miles into the woods for the ostensible purpose to hunt rabbits, continuing their chase until about noon, in the meantime his friends and relatives to the number of sixty or seventy had assembled at his residence and prepared a sumptuous dinner; it looked as though enough to feed a regiment. When uncle Baalam got in about noon with his game expecting to have a roast and was ushered into the crowd, saw the feast prepared for him, to say the least the surprise was complete. Uncle Balam - well he laughed and cried all at the same time. After all had partaken of the feast and passed the usual compliments, the afternoon was spent in having a general good time. We hope he may live to enjoy many such happy birthdays.

Balam Bolin, living in the Morgan edge of Monroe County, died yesterday, aged 66 years. He came to this county when very young, having been born in Clay county, Ky. He was a member of the 67th Indiana regiment during the Civil War and his funeral at 3 o'clock this afternoon was attended by the members of the G. A. R. post of this city. The burial was at the Union cemetery in Baker township. His wife died last September.

The children living are: John Bolin, Mowequa, Ill., who came here last Saturday to attend his father; William, Lawson, Stephen, Douglass, Misses Sarah and Nora Bolin, who live at home; Mrs. Joseph Edwards, of this city, and Mrs. Holda Fulford, who has been living with her father.

Balam Bolin, who was born in Clay Co, KY. Jan. 4, 1829, departed this life March 18, 1895, at his home in Washington township, Morgan Co., Ind. He was married to Anna Goodwin in 1850. To them were born 11 children, ten of whom survive. He became a member of the Christian church in 1870 under the preaching of Eld. J.H. Henry. He volunteered in defense of the Union in 1862 and was taken prisoner at Mumsfordville, Ky.; after serving two years he was discharged on account of ill health. There was a protracted meeting in progress at Union, Morgan Co., when he was buried. By request, Rev. W.H. Krutsinger talked to the audience upon the subject of the first resurrection. The members of the Blankenship Post came out from Martinsville and buried him by the ritual of that post of which he was an honored member. The meeting closed at Union with 18 accepting.

Jackson Bales served in the Mexican War and received a pension at the rate of \$24/month under the Act of January, 1887. After his death his widow Lucinda Bales received the pension. A copy of his pension file is in the pension file box. Copies of Jackson & Lucinda Bales death certificates are in Jackson Bales file.

According to an unpublished manuscript available at the Indiana University Library, Bloomington and called "Monroe County in the Mexican War" by Henry Clay Duncan, 1911, Governor Whitcomb issued a call for volunteers for the war with Mexico April

24, 1847. The companies formed were to report to "Old Fort Clark" near Jeffersonville. Immediately a company called the "Rough and Ready Guards" was formed in Monroe County and reported to the Governor on May 30, 1847. It was officered by Capt. Daniel Lunderman, 1st Lieutenant Wm. McPhetridge, and 2nd Lieutenants Barton Acuff and Thomas A. Reynolds. They became Co. G of the 4th Indiana, commanded by Col. Willis A. Gorman. The company was presented with a flag made by the ladies of Bloomington. The company marched to Columbus, took a train to Madison, and presumably went from there by boat to Jeffersonville. On the 28th of June 1847, the 4th Indiana left Jeffersonville for New Orleans on three steamboats, Captain Lunderman's company going on the steamboat "Franklin". The regiment went from New Orleans to the mouth of the Rio Grande and was a part of General Scott's army and with him went to the city of Mexico. The regiment returned to Madison and was mustered out July 16, 1848, came by rail to Columbus and then marched home on foot. Listed amongst this company were Privates Jackson Bales, James Bales, and Stephen Bales.

Picture of Jackson Bales' headstone in file reads: Jackson Bales Died Aug. 2, 1900 Aged 76 yrs 8 mos 10 dys. Across the bottom in large letters is the name BALES.

After the children were all born in Monroe County, IN the family moved to Morgan Co., IN as told to Dolores Gano by Maude Bales Hubbard in November 1963.

Albert Cooksey married Jane Godsey, daughter of Joseph and Esther (Whisenand) Godsey who was a sister of Elizabeth E. Godsey, wife of Henry Curtis (Curt) Bales, so it is possible Maude and David were related only by marriage through the Bales family. Albert Cooksey lived about six miles northeast of Lebanon on one of Charley Pennington's farms. In 1910 Maude's cousin, Curt Bales (son of Hawkins Bales) moved in across the road from Albert Cooksey to another Pennington farm. White Rock Creek ran through their farm. This was in the Salem area, which was quite a village until the Rock Island Railroad was built and most of the town moved to Esbon and Lebanon. All that remained of Salem was a general store, blacksmith shop, Methodist Church, school and a few family residences. After one to two years the Curt Bales family moved to Illinois. They came back to Kansas in October 1913. Charles F. Bales, son of Curt Bales wrote the book "Twice a Boy" from which this information was taken.

Another connection between these families is that Rebecca Hartsock, whose mother was Rebecca Whisenand, married Willis Hubbard, father of David Hubbard. Obituary of David Hubbard, Lebanon Times, Dec. 13, 1928:

The people of Pawnee were much saddened when they heard of the death of Mr. David Hubbard, who breathed his last on Thursday morning, November 29(sic). His illness was of very short duration though at short intervals for many months his health was frail, complaining of some inwardly trouble which he always bore with remarkable courage and fortitude, knowing that

patience and resignation were most beneficial to his soul hereafter, and also aimed to shield or screen off any species of anxiety from his aged and beloved wife and children. Less than a week prior to his death, he and wife were visiting their son and family who lived about 8 miles from there, realizing probably that it would be his last visit. Soon after he took to his bed and lasted but a few days when his demise came.

Funeral services were held at the Pawnee Union church on Saturday at 1 o'clock. The funeral sermon was preached by the Rev. Lewis E. Ketcherside, Bonna Terra, Missouri, who preached a most eloquent and impressive sermon on the the beautiful traits and exemplary life the deceased had led. After giving in detail a general biography of the deceased, the reverend gentleman then selected his text suitable for the occasion lasting for over an hour. The masterly oration throughout was most touching and affecting through most useful and salutary of the spiritual welfare of the vast assembly who came there on the sad occasion. The funeral procession was one of the largest and most representative that took place in this vicinity for many years, which constituted ample proof of the love and respect deceased was held by all classes in the community.

The deceased was a most devout and attentive member of the "Church Of Christ" which he joined several years ago.

Interment took place in the cemetery south of Lebanon, Kans., where he raised some of his family before moving to Pawnee.

The deceased was born at Bloomington, Ind., February 1849 and died November 22, 1928, aged 79 years.
